#### 2. ELIGIBILITY CRITERIA

#### a) Essential Qualification:

- 1. Graduate in any discipline (10+2+3 pattern) from a recognized University in India.
- 2. Proficiency in Telugu and English languages (reading, writing, and speaking).

The Financial Literacy Counsellor shall:

- 1. Operate from the designated Financial Literacy Centre (FLC) during working hours, 10:00 AM to 5:00 PM on all working days of the bank.
- 2. Provide financial literacy, education, and credit counselling to the public at the designated FLC.
- 3. Conduct at least 10 financial literacy camps per month as per pre-approved schedule.
- 4. Spread awareness about RBI/Government initiatives such as PMJDY, APY, PMJJBY, PMSBY, etc.
- 5. Guide customers on smart savings, responsible borrowing, digital transactions, cyber security, and grievance redressal mechanisms.
- 6. Maintain detailed records of camps conducted and periodic reports to Regional Office & Head Office (FI Department).
- 7. Assist in coordination with NABARD, RSETIs, LDMs, and District Officials in implementing financial inclusion programs.

The Financial Literacy Counsellor shall not engage in loan recovery or money collection, offer investment advice, promote or market any bank's products, handle deposits or funds, or undertake any activity creating a conflict of interest with financial literacy objectives.

#### 7. SELECTION PROCESS

- 1. Eligible applications will be shortlisted based on qualification and experience.
- 2. Shortlisted candidates will be called for personal interview at Head Office, Guntur, or any other venue as decided by the Bank.
- 3. The selection will be based on communication ability, knowledge of financial literacy activities, rural banking exposure, and presentation skills.
