Toll in fire accident at Hyderabad store rises to two

The death toll from the Shalibanda fire rose to two after the shop owner Shiva Kumar Bansal, who sustained 80% burn injuries, died during treatment late on Tuesday night. A major fire broke out on Monday night in an electronics showroom in Hyderabad's neighbourhood, Hyderabad and engulfed the two-floor building, prompting a major emergency response from fire and police officials that lasted for four hours. One person died at the spot, while eight were injured.

Remand prisoner found dead in Kerala jail; foul play alleged

A remand prisoner was found dead under suspicious circumstances at the Kasuragad Sub-Jail in Kerala on Wednesday, following which his family alleged that he was murdered. A police investigation has been initiated into the incident. The deceased, identified as Muhamash of Delhi, was reportedly found unconscious and shifted to a hospital, where he died during treatment. He was arrested on November 5 by the Vidyangan police in connection with a 2016 POCSO case.

Man booked after minor delivers baby at govt. hostel

A 16-year-old Class 10 student residing at the Sri Devaraj Urs Pre-Matric Girls Hostel in Koppal, Karnataka, delivered a baby boy inside the hostel washroom early on Wednesday. The incident has prompted the police to register a case under the Protection of Children from Sexual Offences (POCSO) Act, 2012, against a 23-year-old man. Six others, including hostel staff, teachers, and health workers, have been booked for alleged negligence and failure to protect the minor.

Murugha Mutt seer cleared in one of two POCSO cases

The verdict is in one of the cases against Shivamurthy Murugha Sharana, after two minors from an institution associated with the mutt alleged sexual harassment; two others were also acquitted

The District and Sessions Court in Chitradurga, Karnataka, has acquitted Shivamurthy Murugha Sharana, head of Murugha Mutt, Chitradurga, and two others, accused under the Protection of Children from Sexual Offences (POCSO) Act, 2012.

The seer was among the accused in two POCSO cases filed on allegations of sexually exploiting minor girls. The case was registered in August 2022, after two minor girls from an institution associated with

Gangadhara Channabasappa Hadapad pronounced the judgment on Wednesday, acquitting the accused.

The other two acquitted are Rashmi, warden of the hostel, and Paramashivababu, a manager in the mutt. All the three were present when the verdict was pronounced.

High-profile case

The case was filed at the Nizabazar Police Station in Mysuru on August 26, 2022, and was transferred to Chitradurga Rural Police Station the next day.

The seer was arrested on September 1 that year. The Chitradurga police

filed a charge sheet in the first case on October 27, 2022.


The case had attracted State-wide attention, leading to multiple rounds of investigation, arrest of the seer, and parallel allegations involving individuals connected to the mutt's administration.

The Chitradurga district administration had deployed police around the court on Wednesday after many devotees gathered on the premises. Later, the seer left for Davangere.

Speaking to the media in Davangere, he said he would not react to the judgment at the moment.
